Subject: Adoption of Amendment to Safety Policy Manual re: Lockout / Tagout Policy

It was moved by Mr. Wiggam and seconded by Mrs. Noah to adopt amendment to the Safety Policy Manual as follows:

Lockout / Tagout Policy

Purpose: To prevent accidental or unexpected start-up of machinery or equipment under repair which may cause injury or death.

Scope: All employees or contractors conducting maintenance or service of equipment or machinery when unexpected start-up or release of stored energy is possible.

Wayne County will audit our facilities to identify electrical, pneumatic, hydraulic, or other energized equipment (See Appendix D). These procedures will cover those circumstances where the employee must work near or with exposed energy circuits when guards are removed or when energy could be released that may cause harm to the employee.

I. Lockout / Tagout Procedure

- A. Notify all affected employees that a lockout / tagout system will be utilized.
 1. Authorized employees shall know the type and magnitude of energy of equipment including multiple energy sources.
- B. Shut down machine or equipment by normal stopping procedure.
- C. Machine / Equipment Isolation
 1. Disconnect switch, valve, or energy isolation device from energy source(s).
 2. Machinery with multiple energy sources shall be isolated starting with the main power source.
- D. Lockout / Tagout Device Application
 1. Lockout / tagout device shall be affixed to each isolating energy device by the authorized employee only.
 2. Locks and hasps will be singularly identified by authorized employees.
 3. Lockout devices, when used, shall be affixed in a manner that will hold the energy isolating devices in a "safe" or "off" position.
 4. Tagout devices, where used, shall be affixed in a manner as will clearly indicate that the operation or movement of energy isolating device from the "safe" or "off" position is prohibited.
 5. Following the application of lockout / tagout devices to energy isolating devices, all potentially hazardous stored or residual energy shall be relieved, disconnected, restrained and otherwise rendered safe.

6. After ensuring no personnel are exposed, verify isolation by operating the push button or other normal operating controls to make sure the equipment will not operate.
7. Make sure the operating controls are returned to the “safe” or “off” position.
- E. Removal of Lockout / Tagout Devices
 1. Authorized employee checks machinery for tools and material to be removed.
 2. Ensure all safety guards are in place.
 3. Notify all affected employees that the machinery or equipment is being placed in operation.
 4. Authorized employee to remove locks and tags from energy isolating devices.
- F. Outside Personnel (contractors, subcontractors)
 1. Wayne County employees and outside contractors must inform one another of their lockout / tagout procedure.
 2. Wayne County employees shall advise other employees of outside contractor’s energy control procedures.

II. Conditions That Exempt Equipment from the Written Procedures for Each Piece of Equipment

- A. Equipment has no potential for stored energy after shutdown.
- B. The equipment has a single energy source that can be readily identified and isolated.
- C. The locking out of the energy source will completely de-energize and de-activate the equipment.
- D. The equipment is isolated from the energy source and locked out during servicing or maintenance.
- E. A single lockout device will achieve a locked out condition.
- F. The servicing or maintenance does not create hazards for other employees.

III. Inspection / Audits

- A. Annual effectiveness of the Lockout / Tagout Program will be evaluated and recorded by the Safety / Loss Control Manager.
- B. Each department must document and log each time the program is utilized.

Subject: Adoption of Amendment to Safety Policy Manual re: Noise Exposure and Hearing Conservation Plan

It was moved by Mr. Wiggam and seconded by Mrs. Noah to adopt amendment to the Safety Policy Manual as follows:

Noise Exposure and Hearing Conservation Plan

Purpose: To prevent hearing loss due to occupational noise exposure

Scope: All Wayne County employees exposed to noise exceeding 85 decibels (TWA).

Wayne County will audit departments and measure noise levels which will be listed in Appendix F.

I. Responsibilities

A. Managers and Supervisors

1. Wayne County shall govern a continuing and effective hearing conservation program whenever employee noise exposures equal or exceed an 8 hour time weighted average (TWA) sound level of 85 decibels. (See table 1).
2. Management shall assure noise controls are properly considered in the selection and development of new facilities and equipment.
3. Supervisors shall ensure their employees wear protection in areas exceeding or equal to 85 decibels

B. Safety / Loss Control

1. The hearing conservation program is administered by the Safety / Loss Control Manager. The policy includes the following elements and responsibilities:
 - a. identification of noise hazards
 - b. noise testing and monitoring
 - c. recordkeeping of noise surveys and audits
 - d. hearing protection equipment
 - e. engineering controls
 - f. audiometric testing
 - g. employee training
 - h. training documentation and control

II. Hearing Conservation and Monitoring Program

- A. Wayne County shall administer a continuing and effective hearing conservation program whenever employee noise exposures equal or exceed an 8 hour time weighted average (TWA) of 85 decibels.
- B. When tests indicate that an employee’s exposure may equal or exceed an 8 hour TWA of 85 decibels, Wayne County shall implement a monitoring program.
- C. The monitoring program shall be designed to identify employees for inclusion in the hearing conservation program and to enable the proper selection of hearing protection.
- D. Monitoring shall be repeated whenever an equipment or process change increases more exposure.
- E. Employee Notification
 - 1. Wayne County shall notify each employee exposed at or above an 8 hour TWA of 85 dBA from the results of the monitoring.
- F. Audiometric Training and Testing
 - 1. Wayne County shall establish and maintain an audiometric testing program provided to all employees whose exposures equal or excel an 8 hour TWA of 85 dBA.
 - 2. The program shall be provided at no cost to the employee
 - 3. Audiometric tests shall be performed by a licensed or certified audiologist or other physician.
 - 4. Wayne County shall obtain a valid baseline audiogram written 1 year of an employee’s first exposure at or above the action level.

III. Training

- A. Annual training of hearing conservation will be performed by the Safety / Loss Control Manager.
- B. Employees who are exposed to equal or above the action level are required to participate in the training sessions.
- C. Training shall include:
 - 1. effects of noise on hearing
 - 2. purpose of hearing protection
 - 3. fitting
 - 4. care of equipment
 - 5. purpose of audiometric testing

IV. Records

- A. Records are retained by the appointed authority.
- B. Noise exposure measurements are to be retained for at least 3 years.
