
WHEREAS, the Medway Drug Enforcement Agency has requested authorization for application and pre-grant award conditions and designation as implementing agency for the program;



Subject: **Resolution Declaring Intent to Proceed with Election on the Question of an Additional Tax in Excess of the Ten-Mill Limitation (RC Section 5705.222; RC Chapter 5126; DD Levy)**

It was moved by Mrs. Obrecht and seconded by Mr. Carmichael that the following resolution be adopted:

WHEREAS, on November 25, 2015, the Board passed a resolution declaring the necessity, for the purpose of the operation of programs and services by county boards of developmental disabilities and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities, to levy an additional tax in excess of the ten-mill limitation in the amount of 1.00 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation for 5 years; and

WHEREAS, the Wayne County Auditor has certified to the Board that the dollar amount of revenue that would be generated by such additional tax levy during the first year of collection is \$2,262,500.00, based on the current tax valuation of the County of \$2,356,632,130.00;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, two-thirds of all of the members elected thereto concurring, that:

Section 1. The Board desires to proceed with the submission of the question of the additional tax levy to the electors of the County.

Section 2. The question of such additional tax levy shall be submitted to the electors of the County at the election to be held therein on March 15, 2016 (the "Election Date").

Section 3. The form of the ballot to be used at said election shall be substantially as follows:

PROPOSED TAX LEVY (ADDITIONAL)

WAYNE COUNTY, OHIO

WAYNE COUNTY BOARD OF DEVELOPMENTAL DISABILITIES

A Majority Affirmative Vote Is Necessary For Passage

An additional tax for the benefit of the Wayne County Board of Developmental Disabilities, Ohio for the purpose of the operation of programs and services by county boards of developmental disabilities and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities, at a rate not exceeding 1.00 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation, for 5 years, commencing in 2016, first due in calendar year 2017.

Section 4. The Clerk of the Board is hereby directed and shall certify, not later than December 16, 2015 (which date is not less than 90 days prior to the Election Date), to the Wayne County Board of Elections a copy of the resolution of November 25, 2015 and a copy of this Resolution together with the dollar amount of revenue that would be generated by the additional tax levy during the first year of collection, based on the current tax valuation of the County, as estimated by the Wayne County Auditor.


Section 5. The Clerk of the Board is hereby directed and shall simultaneously certify to the Wayne County Board of Elections, that the additional tax levy will be for the purpose of the operation of programs and services by county boards of developmental disabilities and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities for 5 years and that the levy will be placed upon the tax list and duplicate for the 2016 tax year (commencing in 2016, first due in calendar year 2017) if approved by a majority of the electors voting thereon.

Section 6. All formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


