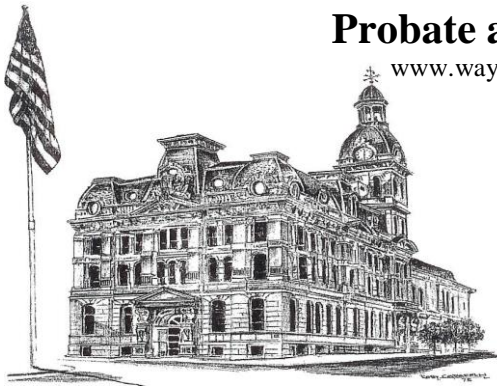

EMPLOYMENT OPPORTUNITY:

ACCOUNT & GRANT CLERK 2

The Wayne County Probate and Juvenile Court is seeking to fill an immediate opening for a permanent Account and Grant Clerk 2. The minimum starting salary for this position is \$21.73 per hour, but a higher starting wage is negotiable based upon prior relevant experience. This position serves at the pleasure of the Judge and reports to the Court Administrator.

Account & Grant Clerk 2 Job Duties and Responsibilities (not a comprehensive list):

1. Completes and submits various reports, including financial reports;
2. Maintains inventories for court supplies;
3. Tracks expenses for court staff and operations;
4. Reviews and perfects invoices and other financial documents for proper submission and tracking;
5. Processes accounts receivable;
6. Drafts, develops, and revises budgets in accordance with court goals and objectives;
7. Issues checks for expenses, payments, and payroll;
8. Drafts and reviews various documents, including but not limited to correspondences, contracts, requests for proposals, grant applications, grant awards, and resolutions;
9. Answers telephone calls and other direct communications from the public; and
10. Any other duties which the Judge, Magistrates, or Court Administrator may assign.

Education and Experience Requirements: A high school diploma or equivalent is required. Prior experience with fiscal procedures and budgeting is required.

Applications: Submit a resume in writing by regular U.S. Mail, with cover letter, which must be **received** on or before December 9, 2022, to the Wayne County Probate and Juvenile Court, Attn: Court Administrator, 107 W. Liberty Street, Wooster, Ohio 44691. **You must complete a Wayne County Employment Application and submit it with your resume in order to be considered for the position of Account & Grant Clerk 2.**
