The Board of County Commissioners of Wayne County, Ohio, will accept sealed bids on or before **2:00 p.m. local time on Tuesday, February 14, 2023**, for: **Bituminous Mix Materials (Hot Mix, Cold Mix, Etc.)**. The purpose of this bid process is to establish unit pricing for various Bituminous Mix Materials (hot mix, cold mix, etc.) for the Wayne County Engineer. The Engineer will place orders for all materials on an as-needed basis. The Board and the Engineer give no guarantee that any minimum or maximum quantity of any material will be ordered or purchased under any contract(s) resulting from this bid process. Any bid not received by the Board of County Commissioners' Office located at Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691 at or before the deadline will be disqualified.

Bidders shall submit one (1) original and one (1) copy of their Bid Proposal in a sealed envelope that is clearly marked with the project name. The outside of the sealed envelope shall also include the name and address of the bidder. If a bid proposal is submitted by mail, the sealed envelope containing the bid proposal must be enclosed in an outer envelope addressed to the Board and designated as a bid for the project. Bids submitted before the deadline will be read opened and read aloud in the Meeting Room on the Upper Level of the Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691, shortly after the deadline. Bidders are asked to send a maximum of one (1) representative per bidder to the bid opening. The bid opening will also be available via Zoom to individuals who register at <https://www.wayneohio.org/wayne-county-commissioners-public-meeting-details>.
