The Board of County Commissioners of Wayne County, Ohio, will accept sealed bids on or before **2:00 p.m. local time on Tuesday, June 7, 2022**, for the:

MORELAND ROAD REHABILITATION PROJECT

All questions must be submitted in writing, via email, to the individual named above. Bidders are responsible for ensuring that all emails are sent and received.

Bids must be submitted on the forms provided in the Invitation to Bid, all blanks of which must be accurately and appropriately completed. Bid proposals must be submitted to the Board of County Commissioners of Wayne County, Ohio, at 428 West Liberty Street, Lower Level, Wooster, Ohio 44691. Bidders shall submit one (1) original and one (1) copy of their Bid Proposal in a sealed envelope that is clearly marked: **BID FOR MORELAND ROAD REHABILITATION PROJECT**. The outside of the sealed envelope shall also include the name and address of the bidder. If a bid proposal is submitted by mail, the sealed envelope containing the bid proposal must be enclosed in an outer envelope addressed to the Board and designated as a bid for the project.

Any bid not received at or before **2:00 p.m. local time on Tuesday, June 7, 2022** will be disqualified. Shortly after the deadline for the submission of bids, any bids received on time will be publicly opened and read aloud in the Meeting Room on the Upper Level of the Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691. Due to the ongoing COVID-19 pandemic, bidders are asked to send a maximum of one (1) representative per bidder to the bid opening. The bid opening will also be available via Zoom to individuals who register for the meeting.

Any bid may be withdrawn prior to the scheduled time for the opening of bids or authorized postponement thereof. No bidder may withdraw a bid within sixty (60) days after the actual date of the bid opening.
