

LEGAL NOTICE

The Board of County Commissioners of Wayne County, Ohio, will accept sealed bids on or before **2:00 p.m. local time on Tuesday, July 12, 2022**, for the: **Care Center Floor Project**. The project is for the purchase and installation of commercial grade flooring in the main hallways and group rooms of the Wayne County Care Center. Any bid not received by the Board of County Commissioners' Office located at Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691 at or before the deadline will be disqualified.

Bidders shall submit one (1) original and one (1) copy of their Bid Proposal in a sealed envelope that is clearly marked with the project name. The outside of the sealed envelope shall also include the name and address of the bidder. If a bid proposal is submitted by mail, the sealed envelope containing the bid proposal must be enclosed in an outer envelope addressed to the Board and designated as a bid for the project. Bids submitted before the deadline will be read opened and read aloud in the Meeting Room on the Upper Level of the Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691, shortly after the deadline. Due to the ongoing COVID-19 pandemic, bidders are asked to send a maximum of one (1) representative per bidder to the bid opening. The bid opening will also be available via Zoom to individuals who register at <https://www.wayneohio.org/wayne-county-commissioners-public-meeting-details>.
