

LEGAL NOTICE

The Board of County Commissioners of Wayne County, Ohio, will accept sealed bids on or before **2:00 p.m. local time on Tuesday, July 12, 2022**, for the: **MORELAND ROAD REHABILITATION PROJECT**. This project is for the rehabilitation by full depth reclamation and resurfacing of Moreland Road (CR077) from Honeytown Road (CR054) to Fountain Nook Road (CR187), a distance of 4.37 miles. Also included in this contract is the installation of aggregate berms. This project must be completed by **Friday, October 7, 2022**. The Engineer's estimate for this project is a base cost of **\$673,740.00**. Any bid not received by the Board of County Commissioners' Office located at Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691 at or before the deadline will be disqualified.

Copies of the Invitation to Bid, which includes the contract terms and specifications, may be obtained from the Wayne County Engineer's office, located at 3151 W. Old Lincoln Way, Wooster, Ohio 44691. All questions must be submitted in writing, via email, to the individual named above. Bidders are responsible for ensuring that all emails are sent and received.

Bidders shall submit one (1) original and one (1) copy of their Bid Proposal in a sealed envelope that is clearly marked with the project name. The outside of the sealed envelope shall also include the name and address of the bidder. If a bid proposal is submitted by mail, the sealed envelope containing the bid proposal must be enclosed in an outer envelope addressed to the Board and designated as a bid for the project. Bids submitted before the deadline will be read opened and read aloud in the Meeting Room on the Upper Level of the Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691, shortly after the deadline. Due to the ongoing COVID-19 pandemic, bidders are asked to send a maximum of one (1) representative per bidder to the bid opening. The bid opening will also be available via Zoom to individuals who register at <https://www.wayneohio.org/wayne-county-commissioners-public-meeting-details>.
