OTHER BUSINESS: Chippewa Township Zoning Text Amendments

Amend Section 9, add Section 9.03

Section 9.03 Portable Storage Containers (PSC)

A. Portage Storage Containers (PSC) are limited to a maximum of 4% of the total property coverage.

Amend and add to Section 19.01 Definitions

Local Retail Business: Low-Intensity Retail, Rental, Office and Personal Services establishments that can be compatibly located on small lots close to residential uses with adequate off-street parking facilities as well as efficient and safe methods of handling vehicular and pedestrian traffic.

Retail Business: A business which prepares, *rents* and/or sells consumer products and goods directly to consumers.

Staff recommendation

The Commission "... shall recommend the approval or denial of the proposed amendment or the approval of some modification of it and shall submit its recommendation to the township zoning commission. The recommendation shall be considered at the public hearing held by the township zoning commission on the proposed amendment." Ohio Revised Code 519.12 (E)

The proposed zoning amendment, to amend Section 9.03, Portable Storage Containers. As well as add to section 19.01 Definitions. Local Retail Business and Retail Business.

Planning staff believes that the language is fair and reasonable. Staff would recommend approval to the Planning Commission for the addition and modification of multiply sections.
