### Section 9.03 Portable Storage Containers (PSC)

a. Portable Storage Containers (PSC) are limited to a maximum of 4% of the total property coverage.

#### Amend and add to Section 19.01 Definitions

**Local Retail Business:** Low-Intensity Retail, Rental, Office and Personal Services establishments that can be compatibly located on small lots close to residential uses with adequate off-street parking facilities as well as efficient and safe methods of handling vehicular and pedestrian traffic.

**Retail Business:** A business which prepares, *rents* and/or sells consumer products and goods directly to consumers.
