The Board of County Commissioners of Wayne County, Ohio, will accept sealed bids on or before **2:00 PM local time on TUESDAY, MAY 26, 2026**, for the: **LEHR RD. BRIDGE REPLACEMENT (DESIGN-BUILD)**

This project must be completed by **OCTOBER 30, 2027**, includes the furnishing of design plans, all labor, material and equipment for the replacement of the Bridge located on Lehr Rd. (WAY-TR101-1.94) over Little Killbuck Creek, in accordance with the design-build specifications prepared by Scott Miller, PE., P.S. of the Wayne County Engineer's Office. Engineer's estimate for the project is **\$1,111,406.40**.

All materials and equipment must meet the specifications of the Ohio Department of Transportation and shall include all necessary barricades, signs, lights, watchmen, etc., and work performed shall be under the supervision of the Wayne County Engineer's Office. **ONLY ODOT PREQUALIFIED CONTRACTORS ARE ELIGIBLE TO SUBMIT BIDS FOR THIS PROJECT.**

All forms provided in the Invitation to Bid are to be completed in entirety and the outside of the sealed envelope is to include the name and address of the bidder. Shortly after the deadline for the submission of bids, any bids received on time will be publicly opened and read aloud in the Meeting Room on the Upper Level of the Wayne County Administration Building, 428 West Liberty Street, Wooster, Ohio 44691.
