BARNES PRESERVE PROJECT: PHASE I – WETLAND RESTORATION

The project is for construction services for Phase I of the Barnes Preserve Project, Wetland Restoration, at the Barnes Preserve, located in Wayne County, at 3396 Sylvan Road, Wooster, Ohio 44691. The Project consists of retrofitting the existing stormwater ponds to construct wetland habitat using excavation and fill around the pond perimeter as well as landscape improvements (Phase I).
