Subject: Resolution Declaring Necessity to Levy an Additional Tax for the Board of DD

in Excess of the Ten-Mill Limitation & Request for Certification from Auditor

It was moved by Mrs. Obrecht and seconded by Mr. Carmichael that the following resolution be adopted:

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the present and future requirements of the Wayne County Board of Developmental Disabilities, Ohio (the "DD Board"), a board subject to the jurisdiction of the County; and

WHEREAS, the DD Board has passed a resolution requesting the County to seek voter approval of an additional tax levy for the DD Board for the purpose of the operation of programs and services by county boards of developmental disabilities and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities;

WHEREAS, a resolution declaring the necessity of levying an additional tax outside the ten-mill limitation must be passed and certified to the County Auditor of Wayne County in order to permit the Board to consider the levy of such a tax and must request that the County Auditor certify to the Board the total current tax valuation of the County and the dollar amount of revenue that would be generated by the tax;

- NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, two-thirds of all of the members elected thereto concurring, that:
- Section 1. It is necessary to levy an additional tax in excess of the ten-mill limitation for the DD Board for the purpose of the operation of programs and services by county boards of developmental disabilities and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities.
- Section 2. The question of such additional tax levy shall be submitted to the electors of the County at the election to be held therein on March 15, 2016.
- Section 3. Such additional tax levy shall be at a rate not exceeding 1.00 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation, for 5 years.
- Section 4. Such additional tax levy shall be placed upon the tax list and duplicate for the 2016 tax year (commencing in 2016, first due in calendar year 2017), if a majority of the electors voting thereon vote in favor thereof.
- Section 5. The Clerk of this Board is hereby authorized and directed to certify a copy of this Resolution to the County Auditor and the Board of Elections of Wayne County, Ohio. This Board hereby requests that the County Auditor certify to this Board the total current tax valuation of the County and the dollar amount of revenue that would be generated by the levy if approved by the voters of the County.
- Section 6. All formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Pursuant to R.C. §301.28, the following county office(s) are authorized to accept payments by financial transaction devices: auditor, treasurer, engineer, recorder, prosecuting attorney, sheriff, coroner, park district, board of health, board of county commissioners, the clerk of the probate court, the clerk of the juvenile court, the clerk of the court of common pleas, and the clerk of a county-operated municipal court.

The following expenses may be paid through the use of a financial transaction device: court costs, fines, real estate taxes, personal property taxes, recording fees, auto title fees, vehicle registration fees, and any other fee, cost, assessment, fine, penalty or any other expense owed to a county office under the authority of a county elected official. Under R.C. §955.013, the Auditor is authorized to establish procedures and take actions that are necessary to allow for either the registration of dogs and kennels via the internet, and/or the payment of dog and kennel registration fees by financial transaction devices, including payment by financial transaction devices via the internet.

The specific financial transaction devices that are an acceptable means of payment for county expenses include: credit cards; debit cards; charge cards; pre-paid or stored value cards; or automated clearinghouse network credit, debit, or e-check entry that includes, but is not limited to, accounts receivable and internet-initiated, point of purchase, and telephone-initiated applications, or any other device or method for making an electronic payment or transfer of funds.

The amount authorized as the surcharge or convenience fee for persons using a financial transaction device shall be no more than three percent (3%) of the transaction total for over the counter payments, five percent (5%) of the transaction total for telephone payments, and no more than seven percent (7%) of the transaction total for online payments.

If a payment made by means of a financial transaction device is returned or dishonored for any reason, the payor shall be charged Twenty Dollars (\$20) for each returned or dishonored item. The amount authorized as the surcharge or convenience fee for credit or debit transactions at a kiosk shall not exceed \$10.00 per transaction and the amount authorized as the surcharge or convenience fee for a cash transaction at a kiosk shall not exceed \$3.00 per transaction. When a county office assumes payment of a processing fee, the fee shall not exceed 4.25% of the transaction total.

The Wayne County Board of Commissioners is designated as administrative agent to solicit proposals in accordance with this resolution and R.C. §301.28, subject to the right of the Treasurer to decline within thirty (30) days of the date of this Resolution.
