WHEREAS, the county engineer has recommended a review of the prima-facie vehicular speed limit established by the Ohio Department of Transportation in 1962 for the portion of South Apple Creek Road (County Road 44) between the village of Apple Creek corporation limit and Miller Street (East Union Township Road 1062) in the vicinity of the former Apple Creek Developmental Center, and

WHEREAS, this Board has caused to be made an engineering and traffic investigation upon the section of road described above, and

WHEREAS, it is the belief of this Board that such investigation confirms the assertion of the county engineer that the current prima-facie speed limit of 45 MPH on the portion of South Apple Creek Road (County Road 44) between the village of Apple Creek corporation limit and Miller Street (East Union Township Road 1062) is no longer justified.
