WHEREAS, Wayne County is vulnerable to an array of natural hazards that can cause loss of life and damages to public and private property; and

WHEREAS, Wayne County desires to seek ways to mitigate situations that may aggravate such circumstances; and

WHEREAS, the development and implementation of a hazard mitigation plan can result in actions that reduce the long-term risk to life and property from natural hazards; and

WHEREAS, it is the intent of the Wayne County Board of Commissioners to protect its citizens and property from the effects of natural hazards by preparing and maintaining a local hazard mitigation plan; and

WHEREAS, it is also the intent of the Wayne County Board of Commissioners to fulfill its obligation under Mitigation Planning, of the Robert T. Stafford Disaster Relief and Emergency Assistance Act to remain eligible to receive state and federal assistance in the event of a declared disaster affecting Wayne County; and

WHEREAS, Wayne County, in coordination with the Cities of Orrville, Rittman and Wooster and the Villages of Apple Creek, Burbank, Congress, Creston, Dalton, Doylestown, Fredericksburg, Marshallville, Mount Eaton, Shreve, Smithville and West Salem, has prepared a multi-jurisdictional hazard mitigation plan with input from the appropriate local and state officials; and

WHEREAS, the Ohio Emergency Management Agency and the Federal Emergency Management Agency have reviewed the Wayne County Hazard Mitigation Plan Update for legislative compliance and has approved the plan pending the completion of local adoption procedures;
