WHEREAS, the Wayne County Prosecuting Attorney is charged with the responsibility for prosecuting violations of state law; and

WHEREAS, the Rittman Police Department and the Ohio Bureau of Criminal Investigation is investigating a matter involving long-time local attorney; and

WHEREAS, the Wayne County Prosecuting Attorney desires to avoid even the appearance of impropriety and/or a conflict in reviewing and potentially prosecuting this matter; and

WHEREAS, the Office of the Ohio Attorney General has created a Special Prosecutions Section for the purposes of prosecuting cases at the invitation of a county; and

WHEREAS, the Wayne County Prosecuting Attorney has requested that the Ohio Attorney General review the matter that is the subject of the aforementioned investigation of the Rittman Police Department and Ohio Bureau of Criminal Investigation; and

WHEREAS, the Office of the Ohio Attorney General has agreed to be appointed Special Prosecutor in this matter; and

WHEREAS, Revised Code 305.14(A) allows the Court of Common Pleas to appoint a Special Prosecutor upon the application of the Board of County Commissioners;

NOW, THEREFORE, BE IT RESOLVED that the Board of Wayne County Commissioners authorize application to the Court of Common Pleas of Wayne County, Ohio, pursuant to RC 305.14, to authorize the employment of the Ohio Attorney General, Dave Yost, or his successor, and any Assistant Attorney Generals from his office, as Special Prosecutor, to review, further investigate and, if appropriate, prosecute any criminal proceedings involving the matter that is the subject of the aforementioned investigation of the Rittman Police Department and the Ohio Bureau of Investigation.
