Clarification of Resolution 2021-441 for Approval of Increase in Real Property

Transfer Tax (ORC 322.02)

WHEREAS, pursuant Resolution 2021-441, dated August 18, 2021, the Board of Commissioners, Wayne County, Ohio (Board), approved the increase of the real property transfer tax by twenty cents per hundred dollars or fraction thereof on the transfer of real property, which will bring the total of tax levied on the transfer of real property to a total of forty cents per hundred or fraction thereof as required and permitted under ORC 319.54(G)(3) and 322.02; and

WHEREAS, the Board desires Resolution 2021-441 to go into effect on October 1, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:

Section 1.
