Approval of Permits to Occupy Road Right of Way for Zayo Group, LLC along County Roads in Wayne County, Approval of Agreement for Extended Liability, Indemnification, and Repair Agreement for Permitted Construction and Installation in the Road Right of Way and Approval of Township Agreement for Installation Oversight by Wayne County Engineer's Office

(ORC 5547.03 & 5547.04)

It was moved by Commissioner Foster and seconded by Commissioner Amstutz that the following resolution be adopted:

WHEREAS, Ohio Revised Code Sections 5547.03 and 5547.04 provide that no person, partnership, or corporation shall erect, within the bounds of any highway or on the bridges or culverts thereon, any obstruction without first obtaining the approval of the board in case of highways other than roads and highways on the state highway system and the bridges and culverts thereon; and

WHEREAS, Zayo Group, LLC (Zayo) has applied for a right of way use permit through the Wayne County Engineer's Office to install a bundle of three (3) underground fiber-optic cables within a certain portion of Wayne County, Ohio, which will also encompass the Townships of Wayne, Chester, Green, and Baughman (Townships), covering 29.402 miles of county owned roadway and using a directional bore method of construction instead of an open trench method;

WHEREAS, the Wayne County Engineer has been approached by Zayo regarding a desire to enter into an agreement, providing for the repair of any damage to said road(s) and rights of way as a result of the installation of the cable and providing for performance bonds and indemnification for any loss or damage to the County as a result of the installation of the cable; and

WHEREAS, the Townships have communicated a desire to allow for the Wayne County Engineer to oversee the installation desired by Zayo.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, (Board) that:

Section 1.

The Board approves the permits to occupy the bounds of the county highway or on the bridges or culverts thereon with the installation of underground fiber-optic cabling within a certain portion of Wayne County, Ohio, using a directional bore method of construction under the conditions and terms outlined in the agreement for extended liability, indemnification, and repair agreement for permitted construction and installation in the road right of way, which includes:

- 1. The permission to occupy the bounds of the county highway or on the bridges or culverts thereon for public utility purposes until the Board deems it necessary to order the removal, reconstruction, relocation, or repair of the obstruction.
- 2. The granting of this permit shall not be construed as an abridgment or waiver of any rights which the Board has in exercising its jurisdictional powers.
- 3. If a removal reconstruction, relocation, or repair of the obstruction is deemed required by the Board it shall be promptly undertaken at the sole expense of the owners thereof, with the understanding that no such relocation shall be required in the next five (5) years.

- Failure of the permittee to conform to the provisions of this permit will be cause for suspension, revocation, or annulment of the permit as the Board deems necessary.
- 5. Zayo is responsible for obtaining any required permits or permissions from the City or Townships as may be required, and for any related construction, repair, or restoration of the roads, road rights of way, drainage systems or structures which are a part thereof and shall include any activities undertaken in aid thereof by Zayo.
- Section 2. The Board approves the agreement with Zayo Group LLC for extended liability, indemnification, and repair agreement for permitted construction and installation in the road right of way.
- Section 3. The Board approves the agreement with the Townships of Wayne, Chester, Green and Baughman to have the project resulting from the Zayo Agreement impacting Township roads and subsequently perform any inspection required thereof.
