pursuant to Ohio Revised Code Section 9.38

It was moved by Commissioner <u>Amstutz</u> and seconded by Commissioner <u>Foster</u> that the following resolution be adopted:

WHEREAS, Ohio Revised Code Section 9.38 specifically sets forth the requirements of public officials for the deposit of public moneys received with the treasurer of public office or the properly designated depository and provides for county commissioners to adopt a policy permitting a different time period for deposit of moneys totaling One Thousand Dollars (\$1,000.00) or less; and

WHEREAS, the different time period allows up to three (3) business days from receipt to deposit public moneys totaling One Thousand Dollars (\$1,000.00) or less in lieu of the next business day standard requirement as long as the public moneys are properly safeguarded until deposit; and

WHEREAS, adoption of this different time period will assist in conformity with the requirements regarding the deposit of public moneys;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:

Section 1. Hereby adopts the following policy and procedure for the deposit of public moneys pursuant to Ohio Revised Code Section 9.38:

- a. Public moneys received by a county public office that exceed One Thousand Dollars (\$1,000.00), individually or cumulatively, shall be deposited with the county treasurer or the properly designated depository the next business day from receipt.
- b. Public moneys received by a county public office that are One Thousand Dollars (\$1,000.00) or less, individually or cumulatively, shall be deposited with the county treasurer or the properly designated depository within three (3) business days from receipt.
- c. Public moneys received by a county public office in error shall be presented to the proper county public office no later than the first business day of the week following the week in which received, and that county public office shall deposit the public moneys according to (a) or (b) above.
- d. Public moneys received by a county public office will be properly secured in a lock box, locked file cabinet, safe, or other locked and secured location, until they are deposited pursuant to (a) or (b) above.
