WHEREAS, this Board desires to continue this pro-rata formula;

NOW, THEREFORE, BE IT RESOLVED by the Board of Wayne County Commissioners that the formula for the cost of such insurance as provided on **Exhibit A** (<u>effective 1/1/2022 – 12/31/2022</u>), is approved; and
