Program (ODOT, Office of Aviation)

WHEREAS, the Board of County Commissioners, Wayne, Ohio (Board) proposes taxiway reconstruction to be performed at the Wayne County Airport (BJJ), Smithville, Ohio (Reconstruct Taxiway B1 & C3) due to alligator cracking, large longitudinal cracks and loose asphalt; and

WHEREAS, the estimated cost of the proposed taxiway reconstruction is \$736,349.47; and
