#### MEMORANDUM OF UNDERSTANDING

WHEREAS, the Wayne County Engineer's Office (Engineer) in conjunction with Wayne County Commissioners (Commissioners) and the Wayne County Transportation Improvement District (WCTID) have decided to enter into a Memorandum of Understanding (MOU) with the Rails to Trails of Wayne County (RTWC);

WHEREAS, RTWC desires to construct multi-use trail along the abandoned rail bed from of approximately 1.1 miles from the end of the existing trail 1,800 ft. north of Market St., in Marshallville, Ohio to the crossing at Coal Bank Rd. 1,900 ft. north of Fulton Rd. in Marshallville, Ohio (Project); and

WHEREAS, Engineer has applied for federal grant funding for a Project estimate of \$823,409.00 through the Akron Metropolitan Area Transportation Study (AMATS) grant program through the Ohio Department of Transportation (ODOT); and


WHEREAS, the Grant was approved, with a funding split of 80%, up to a maximum of \$658,727.00, in federal sourced funding from the Transportation Alternatives Set Aside (TASA), and 20% local funding for the Project, estimated at \$164,682 (Local Share);

In consideration of the above agreements, the Parties have agreed to construct the Project as outlined below:

- 1. RTWC will provide the full Local Share amount required for the Project, estimated at \$164,682.00, including any additional funding required to complete the Project in excess of the estimated project budget. RTWC will be required to deposit the Local Share, as shown in the breakdown below, within thirty (30) days after being advised by the Engineer that the funding is required to continue the Project. Failure by RTWC to provide the minimum amount of the Local Share within the prescribed time frame may result in termination of the Project by the Engineer, at the Engineer's discretion.
  - a. RTWC will deposit \$17,036 of the estimated Local Share of the above referenced project share with the WCTID to be used specifically for the Project and in satisfaction of the agreed cost sharing before the engineer and/or architect has been selected.
  - b. RTWC will deposit the remainder of the estimated Local Share for the Project with the WCTID to be used specifically for the Project and in satisfaction of the agreed cost sharing prior to the start of the competitive bidding process required for the Project.
  - c. RTWC will deposit any additional funds with the WCTID which may be required in excess of the Local Share if the construction agreement is above the estimate and the federal maximum has been met prior to the award to a Contractor for the Project.
  - d. For the purposes of section 1, subsections a-c, the WCTID agrees to accept the funds for the purpose of completion of the Project and will make them available to the Engineer accordingly.

- i. Any additional funding above and beyond RTWC's portion which may or may not be received by Engineer from WCTID will not impact the portion owed by RTWC in satisfaction of the cost sharing above.
- 2. As the Project is a public improvement project and is receiving federal grant money to fund the Project, Commissioners are responsible as the contracting authority under the Ohio Revised Code for obtaining engineering and or architect services as well as construction. Commissioners are required to follow the competitive bidding process, procedures, and provisions for advertising and awarding a contract as provided under the Ohio Revised Code and for Federal Procurement requirements based on the grant provider for the Project, as well as any other applicable laws including but not limited to prevailing wage.
- 3. Each of the persons signing below on behalf of any party hereby represents and warrants that s/he or it is signing with full and complete authority to bind the party on whose behalf of whom s/he or it is signing, to each and every term of this MOU.
