WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Wayne County Children Services Board, Ohio; and

WHEREAS, a resolution declaring the necessity of levying a tax under R.C. 5705.24 on the entire territory of Wayne County outside the ten-mill limitation must be passed and certified to the Wayne County Auditor, Ohio in order to permit the Board of County Commissioners of Wayne County, Ohio to consider the levy of such a tax and must request that the Wayne County Auditor certify to the Board of County Commissioners of Wayne County, Ohio the total current tax valuation of Wayne County, Ohio and the dollar amount of revenue that would be generated by the tax; therefore, be it
