WHEREAS, the Standard Fair Housing Program includes public outreach on fair housing information. complaint intake for citizens with fair housing and/or landlord-tenant concerns, fair housing educational trainings performed at least once per quarter for the general public or civic organization, and analysis of local impediments to fair housing choice; and

WHEREAS, the Board seeks to have the Standard Fair Housing Program administered for the PY'23 (2023-2025) CDBG Development Programs term; and

WHEREAS, Community Action of Wayne and Medina Counties (CAW/M) is an Ohio non-profit corporation providing a range of services to low and moderate income households within Wayne and Medina Counties, has extensive background in performing similar services and has indicated its willingness to administer fair housing services for the Board; and

WHEREAS, the Board and CAW/M entered into a Contract to administer fair housing services in compliance with the Standard Fair Housing Program for the term of January 1, 2022 through December 31, 2023, pursuant to Resolution 2021-684, dated December 22, 2021; and
