WHEREAS, Evinto Solutions, LLC ("Envinto") owns the proprietary computer software application known as Optima ("Software"); and

WHEREAS, the Software is intended to be used by representatives, employees, or other authorized users in their capacity or connection with the Court Appointed Special Advocate Program ("CASA"); and

WHEREASE, the Software allows CASA to track and analyze certain data more effectively, to collect and report information to grantors and stakeholders, and to provide a more efficient reporting system for its volunteers and staff; and

WHEREAS, Envinto, on behalf of the Wayne County Juvenile Court Volunteer GAL Program, has prepared an Agreement to provide software services whereby the initial term of the Agreement shall commence upon the date that the Board first accepts this Agreement and shall remain in effect during the period of the selected Subscription Plan with an automatic renewal for the same duration unless either party terminates the Agreement with at least thirty (30) days written notice; and

WHEREAS, the Board may terminate the Agreement at any time during the (60) day Trial Acceptance Period commencing upon the Optima Training start date while remaining liable for payment of the portion of subscription used, implementation and training expenses in an amount not to exceed \$2,215.00; and

WHEREAS, the Board is responsible for payment of training costs in the amount of \$525.00 and Ohio CASA is responsible for payment of the Subscription Fees; and

WHEREAS, the Board of County Commissioners may enter into an agreement to purchase equipment and services at a cost of seventy-five thousand dollars or less per ORC 307.86.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:
