WHEREAS, Enterprise is desirous of constructing an expansion to its facility located at 6800 Chestnut St., Sterling, Ohio 44273 (hereinafter referred to as the "Project") within the boundaries of the aforementioned Enterprise Zone, provided that the appropriate development incentives are available to support the economic viability of said Project; and

WHEREAS, the Board of Wayne County Commissioners by Res. No. 88-578 adopted November 23, 1988 designated the area as an "Enterprise Zone" pursuant to Chapter 5709 of the Ohio Revised Code; and

WHEREAS, the Board of Wayne County Commissioners having the appropriate authority for the stated type of project is desirous of providing AGRI MARK FARMERS CO-OP, INC. with 50% abatement on real property taxes for 10 years due to improvements made because of development of the Project in said Enterprise Zone under Chapter 5709 of the Ohio Revised Code; and

WHEREAS, the Wayne Economic Development Council President has investigated the application of AGRI MARK FARMERS CO-OP, INC. and has recommended the same to the Board of Wayne County Commissioners on the basis that AGRI MARK FARMERS CO-OP, INC. is qualified by financial responsibility and business experience to create and preserve employment opportunities in said Enterprise Zone and improve the economic climate of Wayne County; and

WHEREAS, the project site as proposed is located in the Norwayne School District and the Wayne County Joint Vocational School District and the boards of education of these districts have been notified in accordance with Section 5709.83 and been given a copy of the Application; and

WHEREAS, the Board of Milton Township Trustees has agreed, by Resolution 2023-18, to enter into the agreement with AGRI MARK FARMERS CO-OP, INC.;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners, Wayne County, Ohio that authorization is granted to enter into an Enterprise Zone Agreement negotiated between AGRI MARK FARMERS CO-OP, INC., the Board of Milton Township Trustees and the Board of Wayne County Commissioners; and

BE IT FURTHER RESOLVED, a copy of the agreement shall be submitted to the Ohio Department of Development and the State Tax Commission within 15 days of execution.
