Management & Imaging on Behalf of the Wayne County Recorder (Resolution #2018-

60)

It was moved by Commissioner <u>Hofstetter</u> and seconded by Commissioner <u>Amstutz</u> that the following resolution be adopted:

WHEREAS, This Amendment No. 1 (this "Amendment") is an amendment to that certain Agreement for Records Management and Imaging System made effective as of January 31, 2018 (the "Agreement"), by and between Wayne County, Ohio (hereinafter "Client"), and GovOS, Inc. (hereinafter referred to as "GovOS"), and is made effective as of January 31, 2023 (the "Amendment Effective Date"). References to a "Party" mean Client or GovOS. References to the "Parties" mean Client and GovOS. Capitalized terms utilized, but not defined herein shall have the meaning set forth in the Agreement; and

WHEREAS, Client and Kofile Technologies, Inc. ("Kofile") entered into the Agreement and GovOS is a corporate affiliate to Kofile and the successor-in-interest to the Agreement; and

WHEREAS, the current term of the Services provided pursuant to the Agreement expires January 31, 2023 and Client and GovOS wish to extend the provision of the Services for an additional five (5) years (the "Extension Period"); and

NOW, THEREFORE, in consideration for continued performance, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree the Agreement is amended as follows:

- Section 1. ASSIGNMENT. Client agrees to the assignment of the Agreement from Kofile to GovOS and GovOS hereby assumes all rights and obligations of Kofile under the Agreement. All references to Kofile in the Agreement are hereby amended to be GovOS.
- Section 2. EXTENSION PERIOD. The Parties hereby agree to extend the term of the Agreement and Schedule A thereto for the Extension Period, which period shall expire on January 30, 2028.
- <u>Section 3.</u> PAYMENT DIRECTION. The first sentence (only) of Section 3 "Payment" is hereby deleted in its entirety and replaced with the following:

"Client agrees to pay GovOS for the System and Services in accordance with the payment provisions set forth in any Schedule to this Agreement."

Resolution to consider construction of parking lot for the Wayne County Jail building

project

It was moved by Commissioner <u>Hofstetter</u> and seconded by Commissioner <u>Amstutz</u> that the following resolution be adopted:

WHEREAS, the Board of Wayne County Commissioners is responsible for providing sufficient space for the housing of prisoners in the county jail; and

WHEREAS, the current Wayne County Jail is not of a sufficient size to handle the needs of the Wayne County courts and jail population of same; and

WHEREAS, the annual jail inspection reports from the Ohio Department of Rehabilitation and Correction indicate that the current Wayne County Jail often exceeds inmate capacity; and

WHEREAS, on July 12, 2022, the Ohio Department of Rehabilitation and Correction performed a full service jail inspection of the Wayne County Jail and found it out of compliance with 1 Essential and 12 Important standards of the Ohio Department of Rehabilitation and Correction, some of which deal with insufficient space in the Wayne County Jail for the inmates it houses; and

WHEREAS, the courts and other public agencies within Wayne County have a comprehensive system to provide alternatives to jail, but Wayne County's demand for bed space for inmates still far exceeds the capacity to house same; and

WHEREAS, additional space is needed for the Wayne County Jail; and

WHEREAS, the Board of Wayne County Commissioners had the architectural firm of Strollo Architects review the cost effectiveness of expanding the current Wayne County Jail at its present location compared to building a new jail in a new location; and

WHEREAS, the study, delivered and presented to the public on January 12, 2022, indicated the cost to build a new facility at a different location would be approximately 9 million dollars more than an expansion and a new addition to the current site. This analysis took into consideration that Wayne County already owns the land where the expansion and the new addition would take place making this option more cost-effective; and

WHEREAS, on January 19, 2022, the Board of Wayne County Commissioners passed Resolution #2022-32 and approved the location for renovation and new construction of the Wayne County Jail at its current location; and

WHEREAS, in order to expand the current jail, the Board of Wayne County Commissioners must remove existing parking spaces next to the current jail and provide additional parking space to the planned extension; and

WHEREAS, the parking analysis, required by the City of Wooster and performed by Strollo Architects, indicated that, due to the expansion and addition to the current jail, approximately 89 parking spaces would be lost; and

WHEREAS, the Board of Wayne County Commissioners owns land directly across from the current jail parking lot on W. Larwill Street (Permanent Parcel Numbers 64-01454.000 and 64-01454.001) which would allow for parking up to 75 vehicles; and

WHEREAS, the Board of Wayne County Commissioners has applied to the City of Wooster for the necessary permits and applications to build a new parking lot on the aforementioned parcels; and

WHEREAS, on March 2, 2023 after the Board of Wayne County Commissioners' appearance before the City of Wooster Design and Review Board for a development recommendation on its application for alterations and additions to the Wayne County Jail, the City of Wooster approved the development recommendation, by a unanimous vote; and

WHEREAS, on April 6, 2023 after the Board of Wayne County Commissioners' appearance before the City of Wooster Board of Building and Zoning Appeals to request two variances ("variances"), pursuant to Section 1109.02(d) of the City of Wooster Planning and Zoning Code which zoning use prohibits parking lots as a principal use on the north side of W. Larwill Street and, pursuant to Section 1123.05(b)(6) of the same Code, regarding interior parking lot landscaping on the north side of W. Larwill Street, the Board of Building and Zoning Appeals admitted that the variances met the Code's requirements but it, nonetheless, rejected them due to complaints from neighbors; and

WHEREAS, on April 6, 2023 the Board of Wayne County Commissioners appeared before the City of Wooster Planning Commission requesting Final Development approval for a parking lot on the north side of W. Larwill Street. The Final Development request was only conditionally approved indicating that the Planning Commission did not see the planned new parking lot being detrimental to the City of Wooster and/or the surrounding community thereto; however, it stated that, but for the aforementioned rejection of the variances, the new parking lot would have been approved; and

WHEREAS, the area north of W. Larwill Street, proposed for the construction of a new jail parking lot, is bordered on the east and south sides by areas that have commercial zoning designations which would allow for the construction of the proposed lot; and

THEREFORE, the Board of Wayne County Commissioners, with consideration and deliberation given to all the above, finds that:

- Section 1. It has made a reasonable attempt to comply with all relevant requirements of the City of Wooster and the aforementioned denial of the variances will significantly hinder the public purpose of providing sufficient additional jail space for the Wayne County Jail; and
- Section 2. The Wayne County Jail, including its expansion and renovation, is essential and it would greatly benefit the safety and well-being of Wayne County.
- Section 3. The public necessity and purpose of an expanded jail and new parking lot thereto exceed the harm and impact of the construction upon surrounding property.
- Section 4. Building a new jail in an alternative location is not fiscally practical.

NOW, THEREFORE, BE IT RESOLVED by the Board of Wayne County Commissioners, with consideration and deliberation given to all:

- Section 5. The Board of Wayne County Commissioners hereby approves to overrule the denial of the Board's applications for variances by the City of Wooster Board of Building and Zoning Appeals.
- Section 6. The Board of Wayne County Commissioners hereby authorizes and directs the Wayne County Administrator, on behalf of the Board, to proceed with the procurement process for the construction of the new parking lot on parcel numbers 64-01454.000 and 64-01454.001.
- <u>Section 7.</u> The Board of Wayne County Commissioners hereby incorporate into this resolution all of the aforesaid recitals and they are rendered to be findings by the Board
- Section 8. The Board of Wayne County Commissioners also finds that all formal actions of its Board concerning and relating to the passage of this Resolution were passed in an open meeting of this Board that was properly noticed.
