5705.03, 5705.19(K), 5705.25)

It was moved by Commissioner <u>Amstutz</u> and seconded by Commissioner <u>Hofstetter</u> that the following resolution be adopted:

WHEREAS, the Board of County Commissioners, Wayne County, Ohio (Board) desires to declare by resolution and certify such to the Wayne County Board of Elections that a necessity exists to renew a tax in excess of the ten-mill limitation pursuant to Ohio Revised Code Section 5705.19 (K) for the purpose of the maintenance and operation of a county home, known as the Wayne County Care Center; and

WHEREAS, the Board is currently levying a 0.70 mill operating levy for five (5) years, which is set to expire; and

WHEREAS, Section 5705.03(B) of the Ohio Revised Code states before submitting the question of a tax levy, certification must be requested from the Wayne County Auditor.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:

- Section 1. The Board, two thirds of all members elected thereto concurring, that it is necessary to renew a 0.7 mill operating levy to constitute a tax in excess of the ten-mill limitation on the entire territory of Wayne County, Ohio, for the purpose of the maintenance and operation of a county home, known as the Wayne County Care Center, at a rate not exceeding 0.7 mill for each \$1 of taxable value, which amounts to \$25 for each \$100,000 of the county auditor's appraised value and which levy is a renewal of an existing 0.7 mill levy for five (5) years.
- Section 2. The levy be placed upon the tax list in calendar year 2023, first due in calendar year 2024, in compliance with Ohio Revised Code section 5705.34, if a majority of the electors voting thereon vote in favor thereof.
- Section 3. The question of such tax levy shall be submitted to the electors of Wayne County, Ohio, at the election to be held therein on November 7, 2023.
- Section 4. The Wayne County Auditor is requested to issue the certification within 10 days after receiving this Resolution.
- Section 5. The Clerk of the Board is hereby authorized and directed to certify a copy of this resolution to the Wayne County Auditor.
- Section 6. That all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of the Board which resulted in passage of this resolution were taken in meetings open to the public, in full compliance with the requirements of Ohio Revised Code Section 121.22.

If the subdivision is located in more than one county, the home county auditor (where the greatest taxable value of the subdivision is located) shall obtain the assistance of the other county auditors to establish the total tax valuation of the subdivision.

WHEREAS, the Board of County Commissioners, Wayne County, Ohio (Board) passed Resolution No. 2023-395 declaring the necessity to levy a tax in excess of ten-mill limitation pursuant to Ohio Revised Code Section 5705.19 (K); and

WHEREAS, the Board desires the question of adoption of said tax levy be submitted to the electors of Wayne County at the General election to be held on November 7, 2023 for a renewal of 0.70 mill for each \$1 of taxable value to constitute a tax for the benefit of Wayne County for the purpose of the maintenance and operation of a county home, known as the Wayne County Care Center, at a rate not exceeding 0.70 mill for each \$1 of taxable value, which amounts to \$25 for each \$100,000 of the county auditor's appraised value, for five (5) years commencing in the year 2023, first due in calendar year 2024, if approved by a majority of the electors voting thereon; and

WHEREAS, the Wayne County Auditor has certified, pursuant to Resolution No. 2023-395, dated July 26, 2023, that the estimated dollar amount of revenue what would be collected annually by the tax levy is \$1,917,000, which amounts to \$25 for each \$100,000 of the county auditor's appraised value, based on the current assessed valuation of Wayne County, Ohio;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:

- Section 1. The Board, two-thirds of all members elected thereto concurring, desires to proceed with the submission of the question of a tax levy at the rate of 0.7 mill for each \$1 of taxable value, which amounts to \$25 for each \$100,000 of the county auditor's appraised value, to the electors of Wayne County, Ohio.
- Section 2. The tax levy will be for five (5) years and such levy will include a levy on the tax list in calendar year 2023, first due in calendar year 2024, if approved by a majority of the electors voting thereon.
