Approval of Application Submission for FY2024 RAISE Grant Funding for Safety Improvements to add Buggy Lanes on Kidron Road in Wayne County

It was moved by Commissioner <u>Amstutz</u> and seconded by Commissioner <u>Smail</u> that the following resolution be adopted:

WHEREAS, the Wayne County Engineer has requested approval to submit an application for FY2024 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant for non-motorized vehicle road safety improvements in Wayne County (Project), through the US Department of Transportation; and

WHEREAS, the Wayne County Engineer has identified one (1) location in Wayne County that pose safety hazards to non-motorized traffic to be addressed by the Project as follows:

Addition of 8' buggy lanes on both sides of Kidron Road from SR 241 in Holmes County to Berg Road in Sugar Creek Township, where the speed limit reduces from 55 mph to 35 mph. The project length is 4.63 miles; and

WHEREAS, the Project is estimated to cost \$28,910,000.00; and

WHEREAS, the proposed RAISE grant is expected to cover \$24,850,000.00 (85.97%) of the estimated Project cost; and

WHEREAS, Highway System Improvement Plan (HSIP) Systemic Funds, currently being secured through the Ohio Department of Transportation (ODOT), are expected to fund \$3,560,000.00 (12.31%) of the estimated Project cost; and

WHEREAS, the remaining \$500,000.00 (1.72%) is expected to be funded by the Amish Steering Committee.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Wayne County, Ohio, that:

### Section 1.

The Board approves the application for funding for the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant for non-motorized vehicle road safety improvements in Wayne County (Project), through the US Department of Transportation, estimated for a total cost of \$28,910,000.00 and funded based on the table below, resulting in no cost to the county.
